1. To establish, run and maintain a School, an Engineering College, any Technical Institution, Dental College, Medical College, Management Institution, Computer Institution, Clinic, Nursing Home, Hospital, Health resort, Hostel and residences, Child welfare institutions, Dharamshala, LAW College , B.Ed./B.T.C., any Educational and Vocational Institution, any charitable Institution/ organization, a University anywhere in India for the benefit and use of general public.
2. To purchase, procure, or get acquired any land for the above objects and to make constructions thereon.
3. To acquire/ purchase equipment, materials, instruments or other necessary paraphernalia for the establishment and running of a School, an Engineering College, any Technical Institution, Dental College, Medical College, Management Institution, Computer Institution, Clinic, Nursing Home, Hospital, Health resort, Child care institution, Dharamshala , any Educational and Vocational Institution, any charitable Institution/ organization, a University etc .
4. To engage/ appoint Teachers, Professors, Associate Professors, Asstt. Professors, Readers, Instructors, Administrative Officers and Staff, Lecturers, Director, Dean, Director- General, Advisor, Consultants, Physician, Surgeons, Nurses, Technical Staff, Support Staff, Accounts Officers and Staff, and all employees and servants of good moral character and capable to impart efficiently and economically up to date instructions to students in science, modern science, technology, industrial avocations, research work, personality development, intellectual and other usual pursuits.
5. To procure/ purchase Books, Learning resources, Library, maintain equipment, the Medicines, open a Medicine sale or distribution department in the Hospital/ Health resort etc.
6. To establish, maintain and run a boarding house, hostels, and residential accommodation for students and those connected with the institutions.



7. To do all other things and carry out other functions and incur all expenses for the above objects.
8. To develop a healthy as well as critical attitude towards the development of mental, physical and moral up lift of the students and those connected with the institutions so as to make them good citizens.
9. To apply for and receive Loan or Finance from Govt., Semi Govt. or Private bodies for purchase of properties for the furtherance of the above objects as per the decision of the Board of Trustees.
10. To accept donations, gifts, grants, presents, offering, medicines, books, instruments, and all other equipment in cash or in kind, and to deal with the same for the purposes and objects of the Trust
11. To charge tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.
12. To invest and deposit for transfer and otherwise deal with other matter of the Trust in such a manner as the Trustees deem fit so as to enable the trust to carry out its objects effectively.
13. To train and equip the students so as to be self -supporting in an honorable manner, and lead decent way of life, so as to develop into good, healthy and progressive citizens.
14. To open training centers for students, nurses, and other Officers and staff engaged in the institutions established/ to be established by the Trust.
15. To bring out, encourage, and develop the incentive and research facilities for the students, teachers and other staff, to afford opportunities for research work in art, science, social sciences, music, culture, engineering and technology, management, environment, computers, health care, hospitality, and other areas of interest to industry and society.
16. To open centers for vaccination and taking other preventive measures for the general diseases and for creation, printing, publication, management and distribution of journals, literature, books, learning resources, study material, leaflets, news papers, magazines, periodicals, pamphlets, for educating the masses



17. To develop discretionary conduct and a habit to observe the rule of law and self-restraint.
18. To organize and devise a mechanism for management of the trust and trust properties to carry out the objects of the trust.
19. To grant aid or render assistance to other public charitable trusts or institutions.
20. To participate in various schemes/ projects of Govt. of India/ State Govt.
21. To invest, dispose off, transfer and otherwise deal with the subject matter of the Trust/ Trust fund in such a manner as the Trustees should deem fit so as to enable them to carry on the objects effectively in larger/ overall benefit of humanity/ society and general welfare of the Nation.
22. To do all other things as may be incidental or conducive to the attainment by the Trustees.
23. If any one or more of the objects specified in clauses of these presents are held not to be objects of a public charitable nature, the Trustees shall not carry out such objects as if the same are not incorporated in these presents, but the validity of the Trust created by The Founder as a Trust for public charitable purposes shall not be affected by any manner.

The strength of the Board of Trustees shall not be less than three and not more than Five at any time.

The Board of Trustees shall have the power to appoint new or additional Trustee(s) within the prescribed limit and to fill vacancies in the office of Trustees by majority vote of 2/3<sup>rd</sup> of the total strength of the Trustees.


Any Trustee who acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or is otherwise unfit to continue as Trustee shall be liable to be discharged from its office by a resolution passed by at least 3/4<sup>th</sup> majority of the total Trustees for the time being except the Trustee proposed to be removed from the office, after affording him a proper and reasonable opportunity.

A trustee may submit resignation from the Board of Trustees, if he so desires, or feels incapacitated or incapable of performing his duties or due to any reason whatsoever, and the same may be accepted by The Board of trustees.

It shall be lawful for the Trustees to get themselves reimbursed with the expenses incurred for the maintenance and the other expenditures for the fulfillment of the aims and objectives of the trust.

Proper accounts shall be maintained for trust in respect of income and assets of the trust. The trustees may pay out such stipend and scholarships and on such terms, if any, as they may deem fit as may be commensurate with income of the subject matter of trust.

If any vacancy arises in the Board of Trustees or on account of death, resignation, incapacity or persistent neglect of any trustee, the remaining trustees may opt any person preferably within the families of the present trustees.

Any question arising in the administration of the trust shall be decided by the majority of the trustees acting for the time being.



After the death of the Founder and the first nominee of the Founder as Chairman, the remaining members of the Board of Trust shall be entitled to elect their own Chairman by majority. The Trustees shall be entitled to do each and every thing to spend the money of the trust in any way they think fit in furtherance of the objects of the trust. The trust is irrevocable.

The trust will run as per rules and regulations, by- laws framed by the Board of Trustees.
